

# Strengthening Families Ohio Parent Café Coordinator Training

The Strengthening Families (SF) Ohio Parent Café Coordinator Training will teach participants how to become familiar with the Strengthening Families framework and increase their knowledge of the five protective factors. The workshop will build participants' expertise in the Strengthening Families Ohio Parent Café model. As a result, participants will have the knowledge, tools and resources needed to coordinate Strengthening Families Parent Cafés and train parent hosts in their local area.

The training workshop will teach participants how to:

- Recruit and Train Parent Hosts.
- Plan for and Deliver Parent Cafés.
- Follow Parent Café Best Practices.

The training workshop will include:

- Workshop materials (instructional coordinator manual and handouts).

Certification Process:

- Attend the 2 day Strengthening Families Ohio Parent Café Coordinator Training conducted by an Approved Trainer.
- Conduct a Strengthening Families Ohio Parent Café session in adherence to the Ohio Model and submit all items as indicated on the Strengthening Families Ohio Parent Café Model Fidelity Checklist to the Ohio Children's Trust Fund.
- Certificate verifying training will be administered when all items on the checklist are received and confirmed.
