## Child Day Camp Background Check Review Summary- SFY 2016

Child day camps in Ohio are required to register with the Ohio Department of Job and Family Services (ODJFS) and obtain criminal background checks for all staff. Ohio Administrative Code 5101:2-18 outlines the requirements for child day camps and the responsibility of ODJFS. Each year, ODJFS randomly selects 40 percent of the registered camps to conduct a review of staff background checks to determine compliance. Day camps that are non-compliant must submit a corrective action plan and may be subject to an on-site inspection.

The following is a report of the day camps reviewed in State Fiscal Year 2016. The report also indicates the compliance status, day camps not in operation, number of staff background checks reviewed, the number of staff background checks out of compliance, and the corrective action submitted.

Compliance Status	<u>Compliant</u> - The day camp submitted background checks for all staff listed on the camp roster. <u>Non-compliant</u> - The day camp failed to submit background checks for the number of staff identified in the Staff Out Column.
Corrective Action Status	<u>Fully Addressed</u> - Corrective action received for background checks determined non-compliant. <u>Partially Addressed</u> - Partial corrective action received for background checks determined non-compliant. <u>No Response</u> - Day Camp failed to respond to multiple requests for background check review. (Note: The day camp may not have responded due to not operating at the time of the review request).
