Individuals serving in **dual roles** of both administrator and classroom teacher: The administrator rules review training must be completed first then any additional specialized training hours can be completed with any other SUTQ approved trainings, based on the individual's professional development plan.

Individuals working in a classroom with a **mixed age groups** of toddler, preschool and school age children: The teacher's first year of annual specialized training must be taken based on the age of the youngest child. Subsequent annual specialized training requirement is determined based on the teacher's professional development plan.

Lead Schoolage teachers working with two distinct age groups: The teacher's first year of annual specialized training must be taken in schoolage topics.

Administrators and teachers (except infant/toddler staff who have not completed all 7 of the Infant/Toddler modules) must provide verification of successful completion (C or better or a passing grade for a Pass/Fail course) for each course from an accredited institution of higher education with content related to early childhood education, in lieu of the specialized training requirement. General degree requirements cannot be counted.
