An inflation factor of 4.5% has been added to the costs associated with this reporting period.

The agencies listed below are expected to file a JFS 02911 Single Cost Report for reimbursement ceiling calculation. For those agencies which have completed the cost report filing and desk review process, Title IV-E reimbursement ceilings and cost per diems are listed below and the Cost Report Status column will be blank. If an agency's cost report has been filed but ceilings are not yet established, the Cost Report Status column will read "Received/Desk Review in Process." If an agency has not submitted a cost report, the Cost Report Status column will read "Nothing Filed Yet."

* For ceilings listed with an asterisk, O.A.C. rule 5101:2-47-11(F) was amended on September 1, 2003, establishing a contemporaneous payment system for purchased foster care services. Under this system, your Title IV-E Maintenance Reimbursement Ceiling is set at the statewide maximum ceiling as currently established through Family, Children and Adult Services Procedure Letter 58J. Note 1: Ohio Administrative Code rule 5101:2-47-24 states that approved Title IV-E reimbursement ceilings are based on the provider's (V. Beacon Agency) participation in the Title IV-E reimbursement ceiling amount approval system. The approval system consists of submission of the JFS 02911 Single Cost Report and the agreed-upon procedures and the other required supplements as outlined in OAC 5101:2-47-26.2.

In response to V. Beacon Agency's license being revoked and the fact they never participated in the Title IV-E reimbursement ceiling approval system for state fiscal year 2005, we have managed to set a maintenance reimbursement ceiling for each of V. Beacon Agency's foster home programs for the period 4/1/06 - 9/30/06 by invoking Ohio Administrative Code rule 5101:2-47-11(H). In the absence of a completed cost report and agreed-upon procedures, Ohio Administrative Code rule 5101:2-47-11(H) provides the following:

Title IV-E FCM reimbursement to the Title IV-E agency for a child placed through a PFC provider not participating in the ODJFS Title IV-E PFC reimbursement ceiling amount approval system is limited to the actual maintenance costs for that child, but shall not exceed the uniform statewide maximum rates published annually in a "Family, Children and Adult Services Procedure Letter."

Our website will list the Title IV-E reimbursement ceilings as an asterisk (*) for maintenance (meaning that the ceiling is equal to the statewide maximum which is currently \$118/day) and \$0 for administration. Please note that no Cost Per Diem Breakout amounts will be provided since no actual cost report was received.

For billing/invoicing purposes Title IV-E agencies can do the following for the maintenance and administration costs incurred:

- Maintenance Costs - the agreed-upon foster care placement amount paid by the Title IV-E agency can be listed on the JFS 01925 Title IV-E Monthly FCM Facility Invoice in column 12, Total Maintenance Paid. The agreed-upon foster care placement amount must be equal to the amount the private agency reimburses their foster parents for the maintenance of the children. Additionally, you can include in column 12 the agreed-upon amount paid by your agency for other direct services which include: special diets, clothing, graduation expenses, liability insurance with respect to the child and reasonable travel expense for home ~~provided these expenses are not included in the agreed-upon foster care placement amount.~~
- Administration Costs - the administration costs paid by the Title IV-E agency can be listed on the JFS 01925 Title IV-E Monthly FCM Facility Invoice in column 13, Total Administration Paid. However, the disbursement journal will reflect a \$0 reimbursement for such costs in order to comply with Ohio Administrative Code rule 5101:2-47-11(H).
