<i>Subsidized employment (includes work for disabled persons who are working in an integrated setting for wages consistent with those of non-disabled workers)</i>	Limit of 6-12 months; can be longer for subsidized work for disabled persons; cannot exceed FLSA standards	Daily supervision by employer, work site sponsor or other responsible party	Documentation projected 6 months in advance based on actual hours
<i>Work Experience</i>	Cannot exceed FLSA standards; Cannot combine other activities into WEP	Daily supervision by employer, work site sponsor or other responsible party	Documentation every 2 weeks
<i>On the Job Training</i>	Must be in conjunction with paid employment	Daily supervision by employer, work site sponsor or other responsible party	Documentation projected 6 months in advance based on actual hours
<i>Job Search/Job Readiness (includes life skills training; substance abuse treatment, mental health treatment or rehabilitation activities for those otherwise employable)</i>	Limited to 6 weeks a year; no more than 4 consecutive weeks	Daily supervision by employer, work site sponsor or other responsible party	Documentation daily
