Uploads go through a two step process in CORe: Import (or receiving) and Validation (or processing). Based on the success or failure of these steps, the following status types can be shown for any upload:

- MISSING** The file has not been received from the area, or has not been imported into CORe.
- Rec'd** The file has been received and imported, but not yet processed (validated).
- ERROR** The file has been received and imported but data error(s) were found during the validation step. ODJFS has sent you an error report detailing these errors for you to fix. After fixing, re-generate from QuIC and send to ODJFS to be imported again.
- PROB** The file was received and processed, but an internal error occurred in CORe. These files should be re-generated from QuIC and sent to ODJFS to be imported again.
- OK** The file has been imported and validated successfully.
- [n/a]** No file is expected for this data subset and date type combination, e.g., PA areas do not submit CS-RMS uploads, PCSA areas do not submit CFF uploads, etc.
