## Designated Primary Care Provider(PCP) for Newly Enrolled Members

The percentage of MCP's newly enrolled members who were designated a PCP by their effective date of enrollment.

**Numerator:** Members in the denominator designated a PCP by the effective date enrollment. Designated PCPs will only be included if they have a provider type code listed on the ODJFS' Provider Master File listed below. For PCPs with provider type codes indicating individual physician or osteopath, the individual physicians and osteopaths will only be included if they have a provider specialty code listed on the ODJFS' Provider Master File listed below

**Denominator:**Members who were newly enrolled into the MCP (i.e., without enrollment for the previous month in the MCP) during the annual reporting period.

**Data Sources:**ODJFS' Primary Care Provider Database, Provider Master File

**Report Periods:** The applicable report period for the methods included in this document is:
