NORMAL PAYMENT CYCLES SHOULD RESUME FOR CLAIMS PROCESSED THE WEEK OF JULY 14, 2008 AND THEREAFTER.

A PAYMENT SYSTEM ERROR HAS BEEN IDENTIFIED THAT HAS RESULTED IN LINE ITEMS ON CERTAIN CLAIMS PAYING INAPPROPRIATELY AT ZERO OR DENYING SINCE NOVEMBER 1, 2007. THE ERROR MAY HAVE IMPACTED PAYMENT FOR COVERED SERVICES WITH LIMITS OVER MULTIPLE MONTHS AND YEARS SUCH AS 300 UNITS EVERY 2 MONTHS OR 1 UNIT EVERY 5 YEARS.

PROVIDERS MUST SUBMIT AN ADJUSTMENT FOR THE LINE ITEMS THAT INAPPROPRIATELY PAID ZERO.

PROVIDERS MUST RESUBMIT A CLAIM FOR PAYMENT FOR THE LINE ITEMS THAT INAPPROPRIATELY DENIED

THE SYSTEM ERROR HAS BEEN CORRECTED FOR CLAIMS RECEIVED ON AND AFTER APRIL 11, 2008.

EFFECTIVE 7/1/08, THERE WILL BE A 3% RATE INCREASE FOR ODJFS-ADMINISTERED WAIVER, PRIVATE DUTY NURSING, HOME HEALTH AND THERAPY SERVICES. NEW RATES ARE AS FOLLOWS: WAIVER NURSING, PDN & HOME HEALTH NURSING @ \$56.65/FIRST HOUR AND \$5.87/15 MINUTE UNITS; PERSONAL CARE AIDE & HOME HEALTH AIDE @ \$24.72/FIRST HOUR AND \$3.09/15 MINUTE UNITS; OUT-OF-HOME RESPITE @ \$206.00/DAY; SUPPLEMENTAL TRANSPORTATION @ \$.39/MILE; ADULT DAY HEALTH CENTER SERVICES @ \$66.95/FULL DAY AND \$33.48/HALF DAY; EMERGENCY RESPONSE SERVICES @ \$46.35/INSTALLATION/TESTING AND \$46.35/MONTHLY; AND HOME DELIVERED MEALS @ \$7.21/MEAL..HOME MODIFICATIONS & SUPPLEMENTAL ADAPTIVE/ASSISTIVE DEVICE SERVICES WILL CONTINUE TO BE REIMBURSED THE AMOUNT PRIOR-AUTHORIZED ON THE CONSUMERS ALL SERVICES PLAN. STATE PLAN PT, OT & ST WILL BE REIMBURSED @ \$72.10/FIRST HOUR AND \$4.64/15 MINUTE UNITS. PROCEDURE CODES WILL STAY THE SAME. PLEASE BILL THE NEW RATES FOR SERVICES RENDERED ON/AFTER 7/1/08 TO INSURE PROPER REIMBURSEMENT.
