Monthly Review of Public Assistance Statistics for September 2008

Ohio Works First (OWF)

For the month of September 2008, OWF-Combined assistance groups totaled 80,794; recipients totaled 175,290 and money payments totaled \$27,530,021. The percent change from August 2008 to September 2008 was 0.0% for assistance groups; 0.4% for recipients, and 0.7% for money payments. For OWF- Regular (OWF-R) there were 76,966 assistance groups; 160,131 recipients, and \$25,795,899 in money payments issued for September 2008. The percent change from August 2008 to September 2008 was 0.0% for assistance groups; 0.3% for recipients, and 0.6% for money payments. For OWF-Unemployed (OWF-U), assistance groups totaled 3,828, recipients, 15,159 and money payments were \$1,734,122. The percent change from August 2008 to September 2008 was 1.6% for assistance groups; 1.3% for recipients and 2.5% for money payments.

Foster Care (TITLE IV-E)

Disability Assistance (DA)

For the month of September 2008, there were 17,408 assistance groups; 17,501 recipients, and \$2,264,735 in DA financial assistance. The average DA financial assistance per recipient was \$129.41. Total DA expenditures for medical services for September 2008 were \$ 842,258. Of this total, \$628,654 or 74.6% was spent for prescribed drugs, and \$ 160,476 or 19.1% was spent for physician services. Medical expenses were paid for 1,777 recipients for an average expenditure of \$473.98 per recipient.

Food And Nutrition Services Benefits (FNS) (Food Stamps)

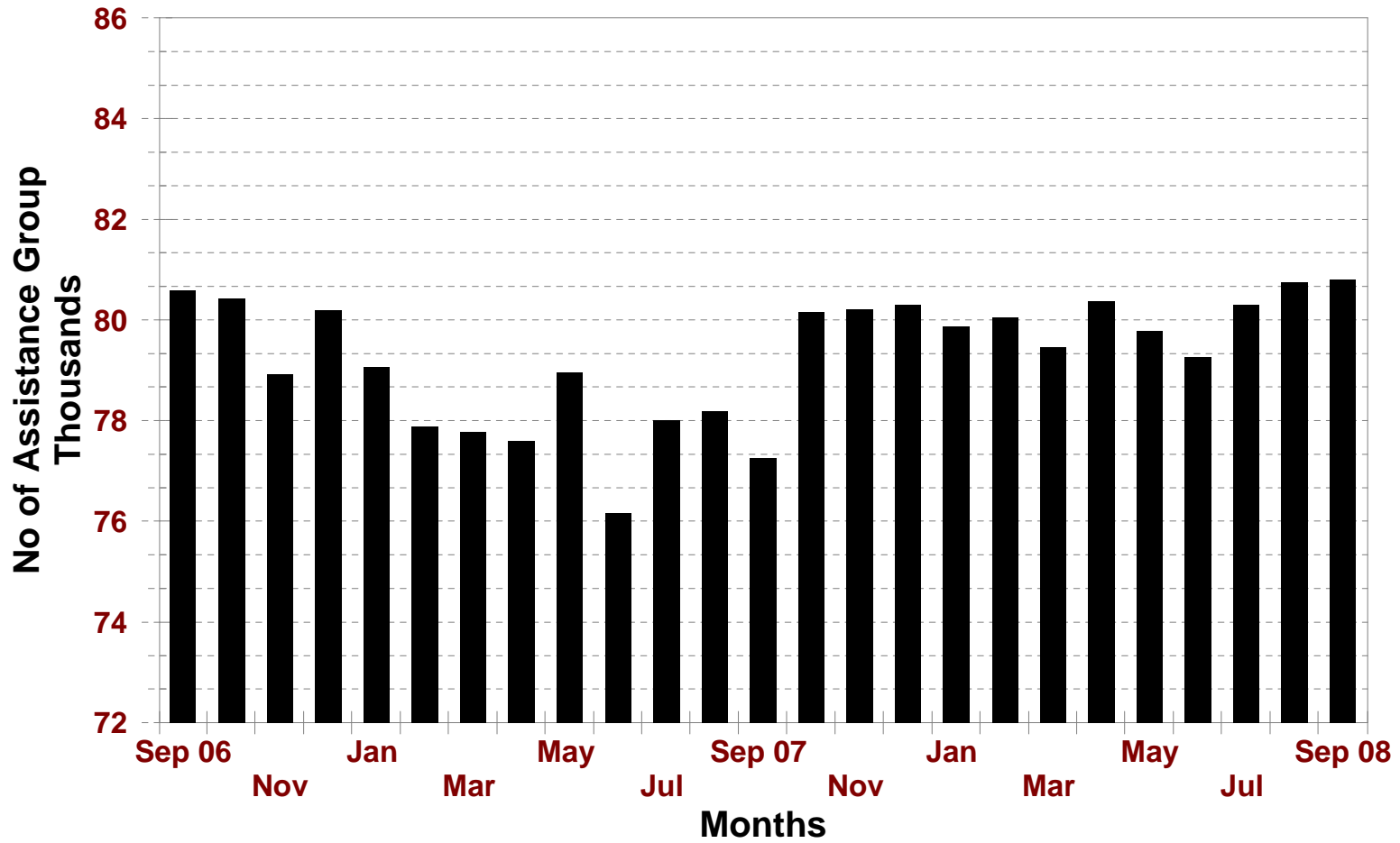
Total persons participating in the FNS benefits program during September 2008 increased to 1,214,935 by 36,323 or 3.1% from 1,178,612 persons reported in August 2008. Households increased by 16,387 or 3.0% over August 2008 levels. The total dollar value of FNS related benefits issued during September 2008 increased by \$ 34,546,626 or 27.5% from \$125,732,006 reported in August 2008 to \$160,278,632 reported in September 2008. The average benefit issuance per person increased by \$ 25.24 or 23.7% from those issued in August 2008. The average benefit issuance per person increased from \$106.68 reported in August 2008 to \$131.92 reported in September 2008.

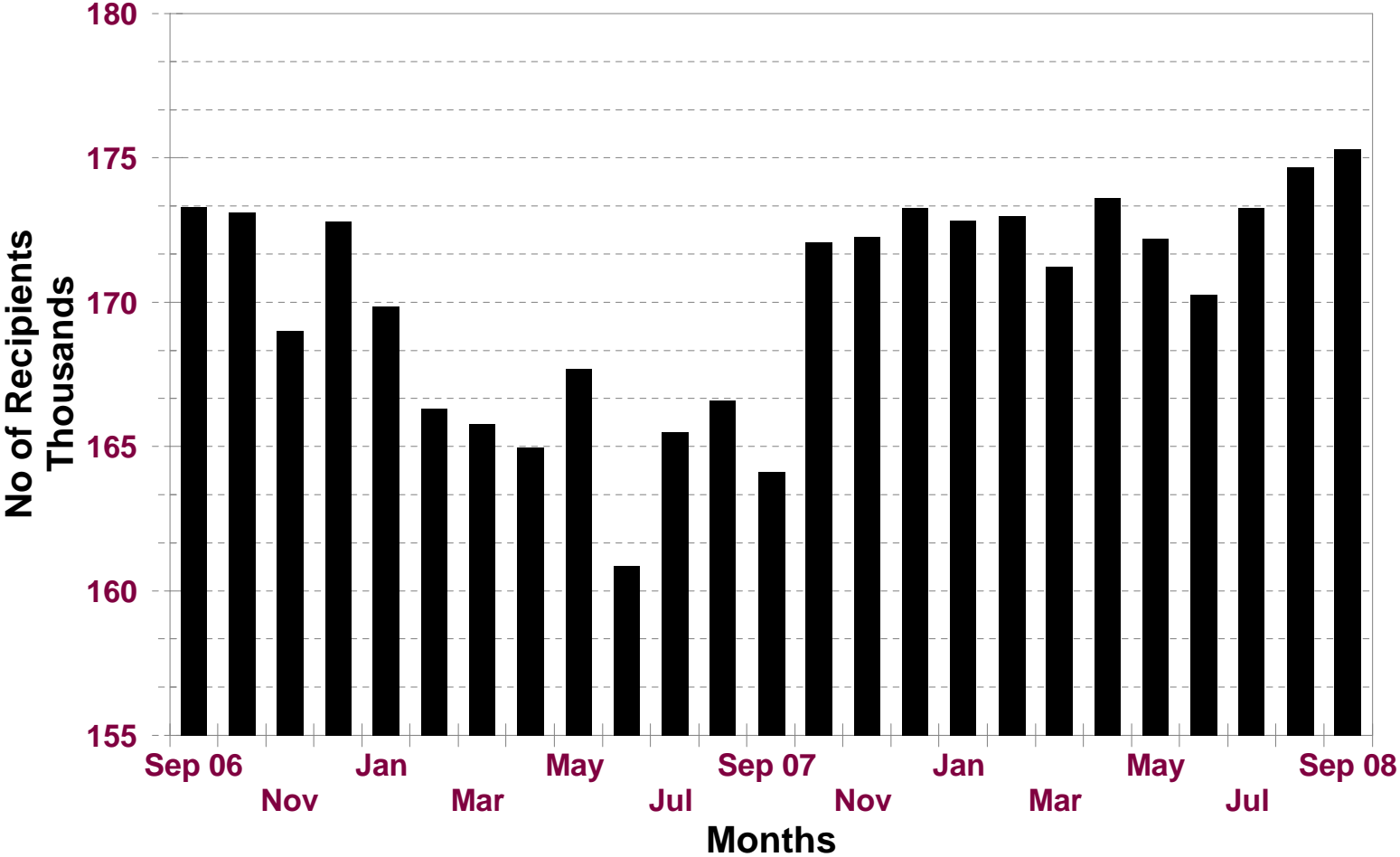

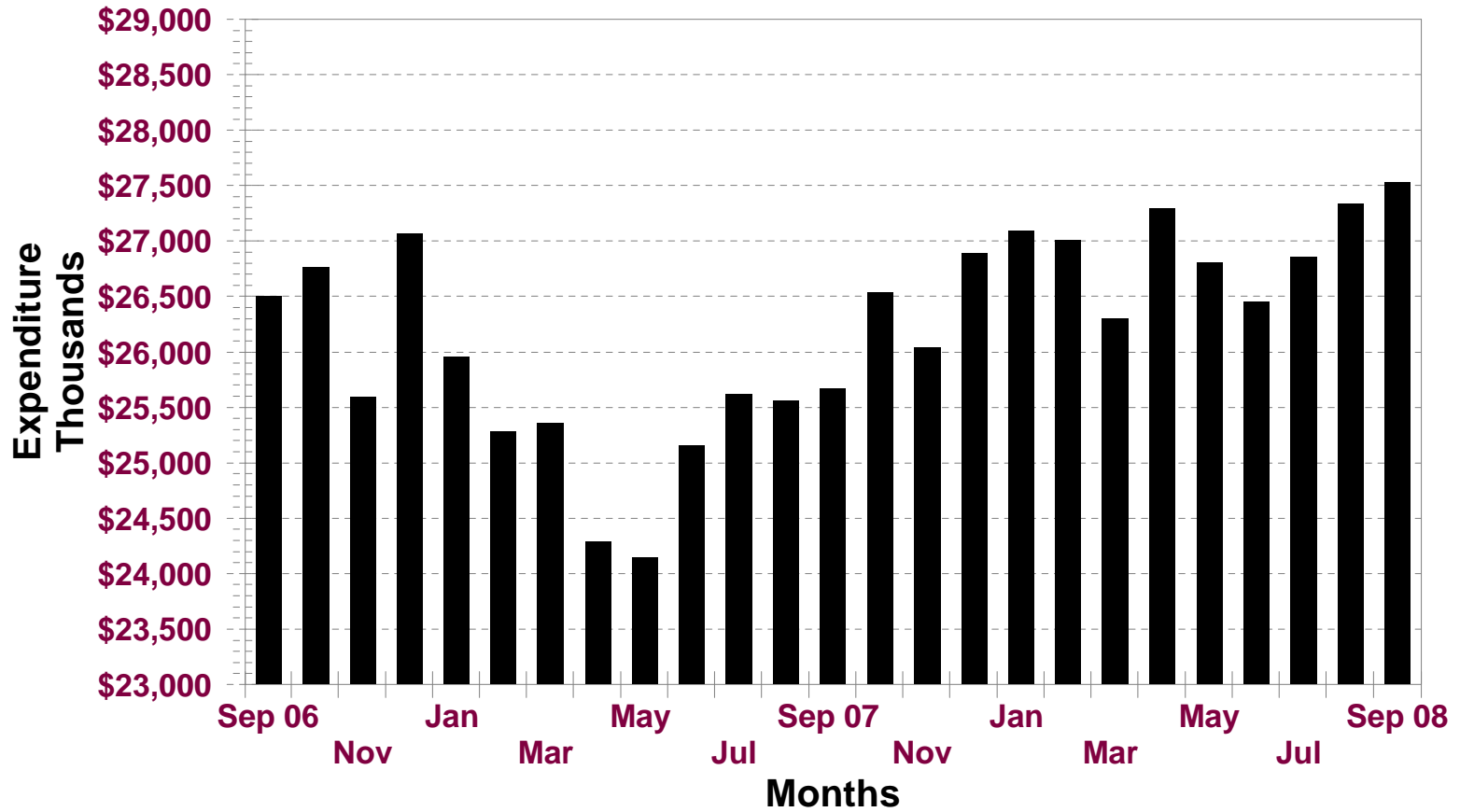
No of OWF Combined Assistance Groups During The Last 25 Months

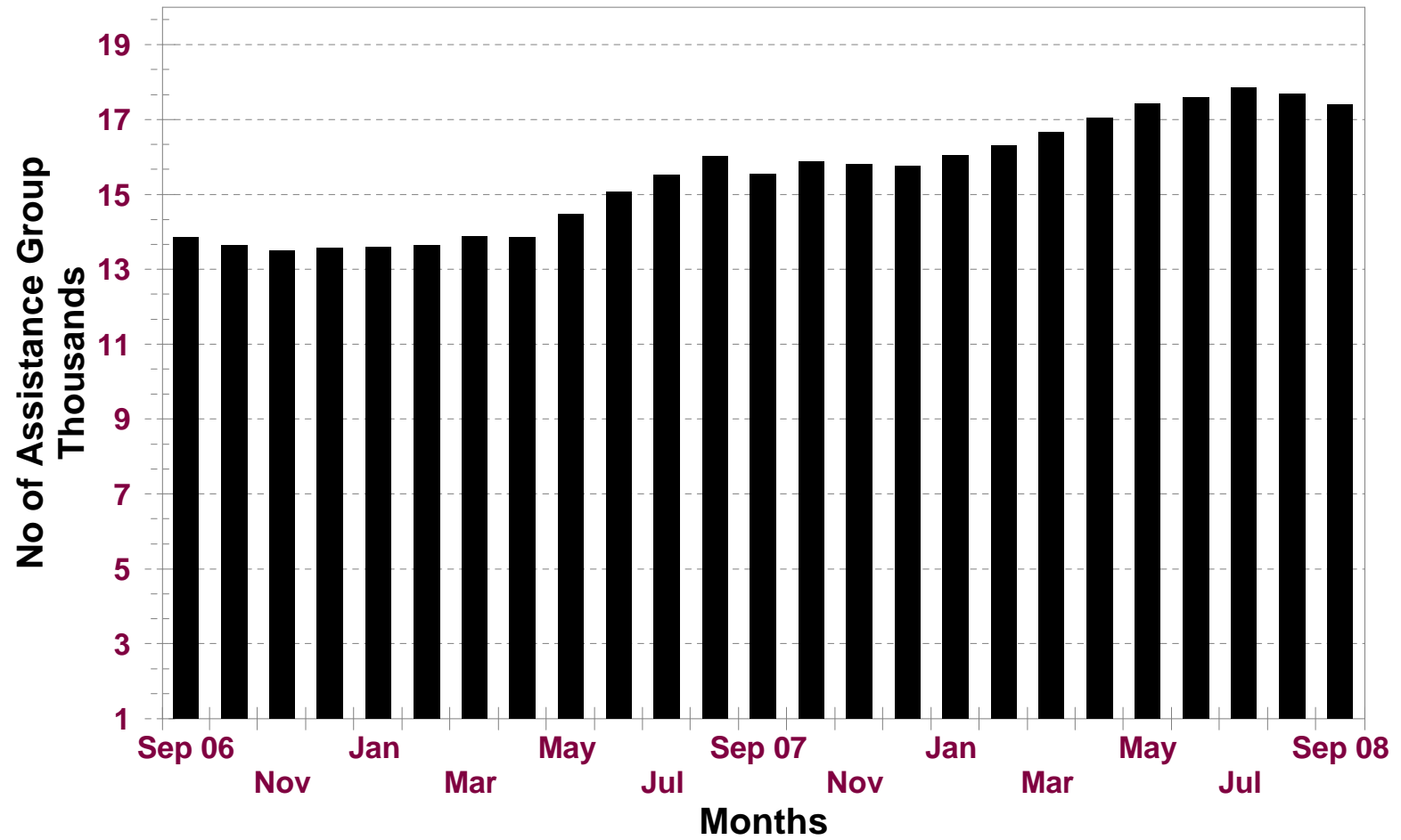

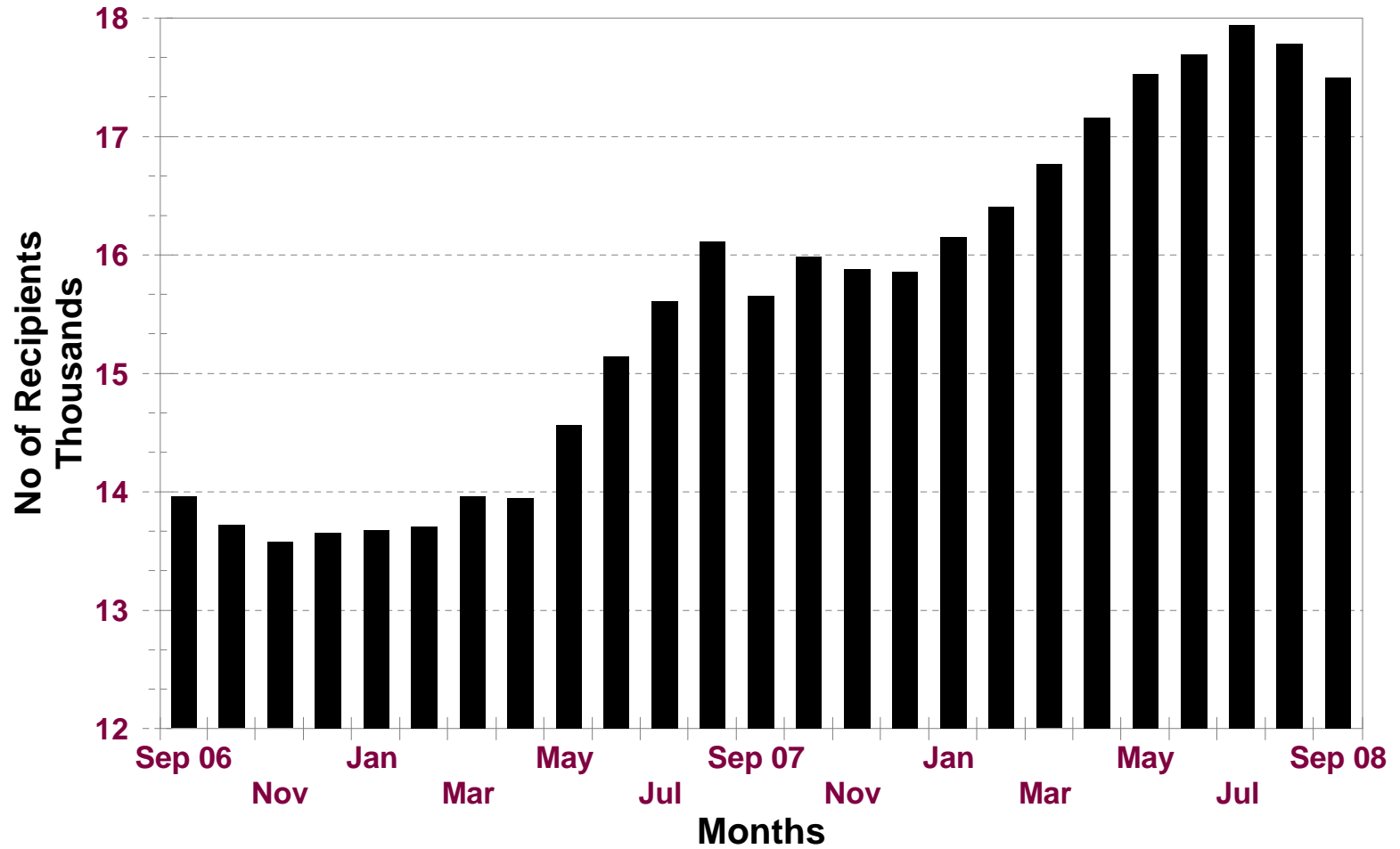

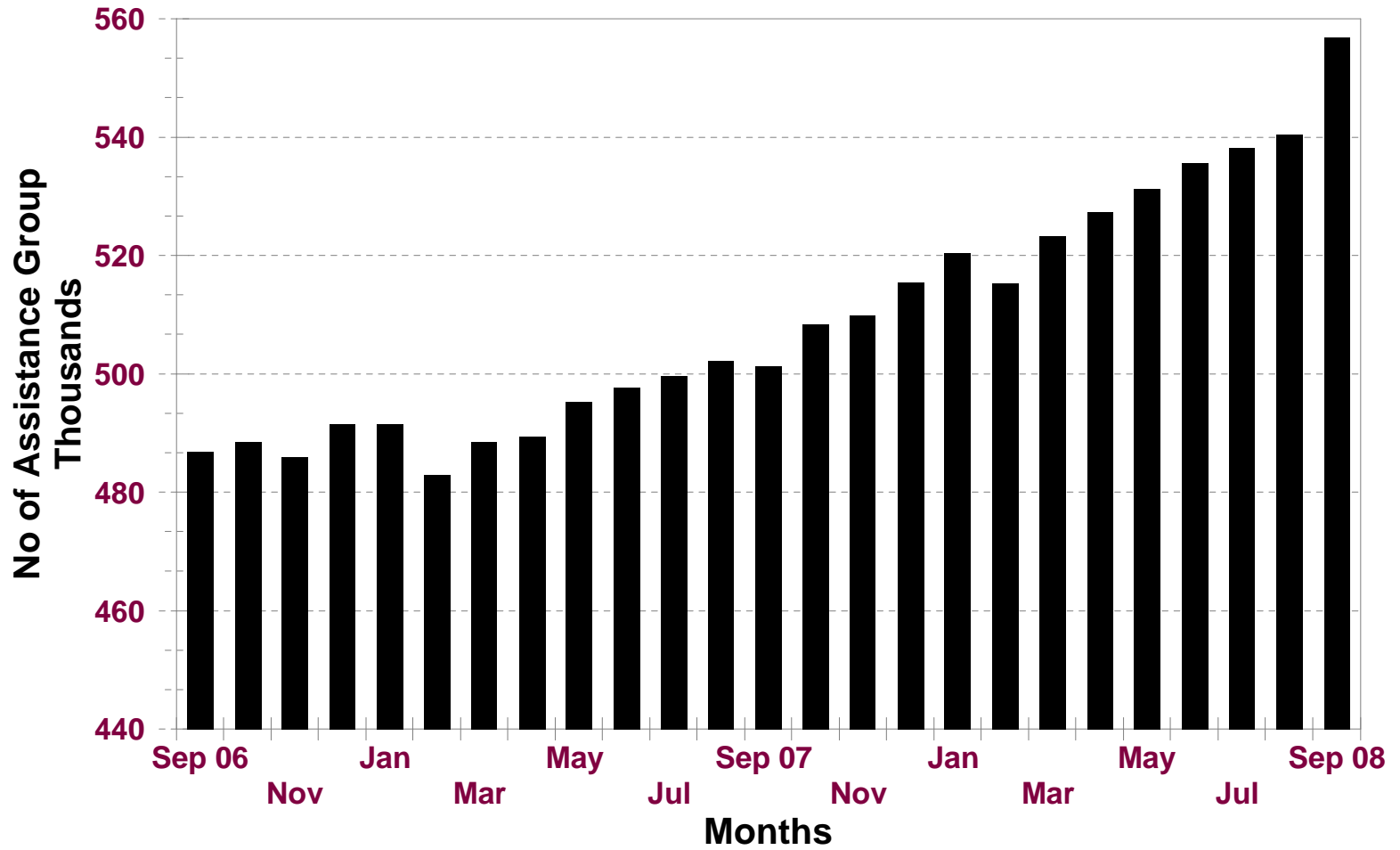

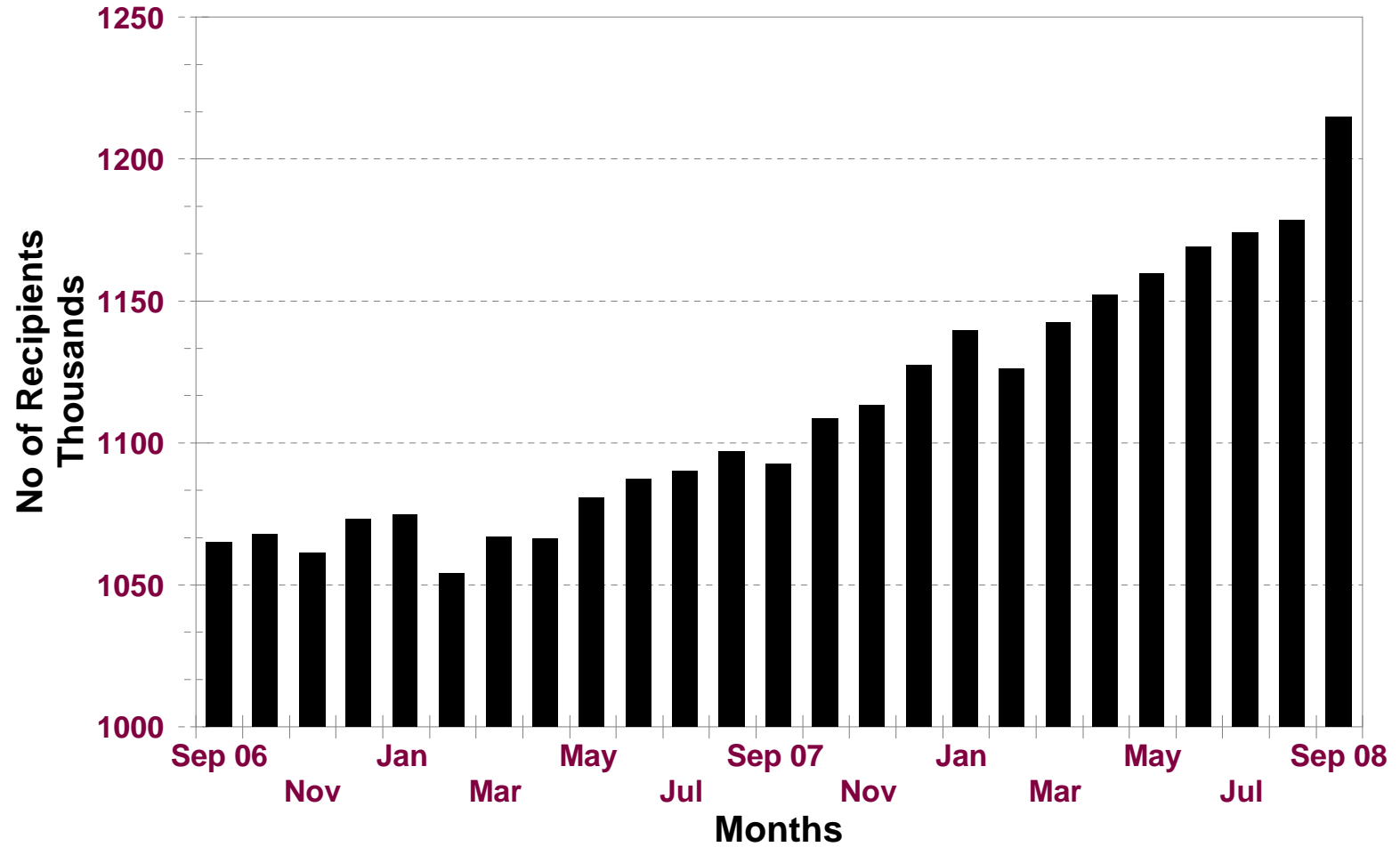
