Monthly Review of Public Assistance Statistics for February 2009

Ohio Works First (OWF)

For the month of February 2009, OWF-Combined assistance groups totaled 85,828; recipients totaled 189,957 and money payments totaled \$31,156,875. The percent change from January 2009 to February 2009 was 1.4% for assistance groups; 1.6% for recipients, and 2.6% for money payments. For OWF- Regular (OWF-R) there were 80,253 assistance groups; 167,891 recipients, and \$28,456,096 in money payments issued for February 2009. The percent change from January 2009 to February 2009 was 0.9% for assistance groups; 0.9% for recipients, and 2.1% for money payments. For OWF-Unemployed (OWF-U), assistance groups totaled 5,575, recipients, 22,066 and money payments were \$2,700,779. The percent change from January 2009 to February 2009 was 7.9% for assistance groups; 6.9% for recipients and 7.8% for money payments.

Foster Care (TITLE IV-E)

Disability Assistance (DA)

For the month of February 2009, there were 16,403 assistance groups; 16,488 recipients, and \$2,195,061 in DA financial assistance. The average DA financial assistance per recipient was \$133.13. Total DA expenditures for medical services for February 2009 were \$789,447. Of this total, \$561,677 or 71.1% was spent for prescribed drugs, and \$172,160 or 21.8% was spent for physician services. Medical expenses were paid for 1,503 recipients for an average expenditure of \$525.25 per recipient.

Food And Nutrition Services Benefits (FNS) (Food Stamps)


Total persons participating in the FNS benefits program during February 2009 increased to 1,306,903 by 19,554 or 1.5% from 1,287,349 persons reported in January 2009. Households increased by 8,628 or 1.5% over January 2009 levels. The total dollar value of FNS related benefits issued during February 2009 increased by \$3,962,816 or 2.5% from \$156,174,484 reported in January 2009 to \$160,137,300 reported in February 2009. The average benefit issuance per person increased by \$1.22 or 1.0% from those issued in January 2009. The average benefit issuance per person increased from \$121.31 reported in January 2009 to \$122.53 reported in February 2009.




No of OWF Combined Assistance Groups During The Last 25 months






Food Stamp Benefits Assistance Groups
