Ohio has seven Child Care Resource and Referral Agencies (CCR&Rs) who have been awarded grants from the Ohio Department of Job and Family Services (ODJFS). The CCR&Rs are required to provide services which include, but are not limited to:

- supporting early care and education providers in increasing the supply and quality of services;
- assisting families in accessing early care and education services;
- supporting community involvement to improve the early care and education system; and
- providing ODJFS and the community with reports and information on the current statistics of early care and education.

There are 12 service delivery areas (SDA) covering the state. To find your SDA, locate your county below:
