LEADERSHIP COMMITTEE DECEMBER SESSION DESIGN DOCUMENT

Overall Purpose of This Work:

The Committee serves to make recommendations to the Ohio Department of Job and Family Services to guide the planning and implementation efforts necessary for the successful fulfillment of the requirements of the Federal Family First Prevention Services Act.

Purpose of This Session:

- To review the next iteration and vote on the leadership committee charter. Particular areas of focus are:
 - proposed deliverables/final products for the leadership committee and potential due date
 - language regarding the values and ways of work, member responsibilities, decision making and voting and communication
 - discussion on a template for the subcommittee charges and documentation of key decisions and action steps needed
- Provide foundational information on Title IV-E funding from national, state and county perspectives including how Medicaid is used for service provision.
- Conduct an overview of FFPSA QRTP requirements and key considerations for OH.
 - Identify the key issues, critical people/expertise needed and necessary decisions related to implementation of the QRTP requirements that could be potential tasks and duties of a subcommittee.

Non-Purposes of This Session:

- Analyzing concerns/considerations for *other* titles within FFPSA.
- Funding and resources to support transition for FFPSA implementation will be addressed, as we get deeper into and closer to initial implementation. The committee is aware that this is a critical issue and will come back to this discussion in the future.
- Speculation on the recent election results and/or upcoming transitions will not be discussed in this session. Any incoming leadership will be informed on the current status of FFPSA implementation efforts and needs regarding readiness and next steps.
- Discussion on transition for counties from implementation of the IV-E waivers to FFPSA implementation.

Background Statements:

- The FFPSA QRTP readiness assessment has been received from providers and the assessment results are ready to be analyzed. The Preventive Services assessment is currently in draft form.
- A match has been made for a project manager through Foster America. Next steps include a candidate visit in December and preparation and approval of a final contract.
