## **LEADERSHIP ADVISORY COMMITTEE JULY SESSION DESIGN DOCUMENT**

### **Overall Purpose of This Work:**

The Leadership Advisory Committee will take a deep dive into the work of the Qualified Residential Treatment Programs Subcommittee. The workgroups have worked diligently to make recommendations to the subcommittee regarding the QRTP treatment models, agency readiness, accreditation, licensing and contraction, court oversight, and Level of Care Assessment tool. In this session, the QRTP Subcommittee will present recommendations to the Leadership Advisory committee for a vote. We will also hear updates from the Prevention Subcommittee regarding the prevention planning and framing.

### **Purpose of This Session:**

- A. Provide updates on the overall progress of the committee, subcommittees, and workgroups.
- B. Provide additional information about the work progress/ implementation planning of the QRTP Subcommittee and present recommendations to Leadership Committee for vote.
- C. Updates on the statewide prevention services.

### **Background Statements:**

- Based on the Act, states cannot begin to pull down funds for the prevention services until they have the QRTP standards in place. With this in mind, JFS leadership has decided to focus in on completing the work of the QRTP subcommittee and do some additional planning for the prevention services.
- Prevention Services is about designing a new way of providing services to eligible populations so there is a need to really focus in simultaneously on design and strategy in addition of assessing the evidence-based provider landscape of the state.
