Overall Purpose of This Work:

The Prevention Subcommittee is planning a retreat to discuss the overall vision for prevention services in Ohio, the candidacy for foster care definition, and the overarching flow for prevention services. This retreat will take place in October and will be facilitated by the Center for the Study of Social Policy (CSSP). In this meeting, CSSP will share and overview of the direction for these planning efforts as well as gather any additional direction from the leadership committee that can inform these efforts.

The QRTP Subcommittee will finalize key deliverables and discuss ongoing work plans. Because this subcommittee is concluding final deliverables, there will be some discussion about implementation and further planning efforts for workgroup whose deliverables extend beyond the work of the QRTP subcommittee.
