For good cause and upon written application ODJFS may grant an extension of the December 31, 2014, filing deadline in accordance with O.A.C. 5101:2-47-26.1. Approved filing deadline extensions are reflected below. Based on this reporting period approved Title IV-E reimbursement ceilings will be effective for the period April 1, 2015, through March 31, 2016. An inflation factor of 3.7% has been added to the costs associated with this reporting period.
