The JFS 02911 Title IV-E Single Cost Report for state fiscal year 2020 covers the reporting period of July 1, 2019, to June 30, 2020. The JFS 02911 Title IV-E Single Cost Report, along with the documents required by O.A.C. 5101:2-47-26.2, must be completed and filed by December 31, 2020.

For good cause and upon written application OQJFS may grant an extension of the December 31, 2020, filing deadline in accordance with O.A.C. 5101:2-47-26.1. Approved filing deadline extensions are reflected below.

Based on this reporting period approved Title IV-E reimbursement ceiling per diem will be effective for the period April 1, 2021, through March 31, 2022. An inflation factor of 1.1% has been added to the costs associated with this reporting period.

Under this system, your Title IV-E maintenance reimbursement ceiling per diem (e.g., the amount paid to the foster parent) is set at the statewide maximum ceiling as currently established through procedure letter in the Family, Children and Adult Services Manual (Procedure Letter No. 360 renews the statewide maximum of \$200/day). Under this system, your Title IV-E maintenance reimbursement ceiling per diem (e.g., the amount paid to the foster parent) is set at the statewide maximum ceiling as currently established through procedure letter in the Family, Children and Adult Services Manual (Procedure Letter No. 360 renews the statewide maximum of \$20/day).
