Monthly Review of Public Assistance Statistics for October 2009

Ohio Works First (OWF)

For the month of October 2009, OWF-Combined assistance groups totaled 99,687; recipients totaled 228,831 and money payments totaled \$36,721,289. The percent change from September 2009 to October 2009 was 1.7% for assistance groups; 2.0% for recipients, and 2.0% for money payments. For OWF- Regular (OWF-R) there were 91,915 assistance groups; 198,133 recipients, and \$33,045,824 in money payments issued for October 2009. The percent change from September 2009 to October 2009 was 1.5% for assistance groups; 1.7% for recipients, and 1.8% for money payments. For OWF-Unemployed (OWF-U), assistance groups totaled 7,772, recipients, 30,698 and money payments were \$3,675,465. The percent change from September 2009 to October 2009 was 4.3% for assistance groups; 4.4% for recipients and 3.8% for money payments.

Foster Care (TITLE IV-E)

Disability Assistance (DA)

For the month of October 2009, there were 14,510 assistance groups; 14,565 recipients, and \$2,002,653 in DA financial assistance. The average DA financial assistance per recipient was \$137.50. Total DA expenditures for medical services for October 2009 were \$690,833. Of this total, \$521,031 or 75.4% was spent for prescribed drugs, and \$122,682 or 17.8% was spent for physician services. Medical expenses were paid for 1,213 recipients for an average expenditure of \$569.52 per recipient.

Food And Nutrition Services Benefits (FNS) (Food Stamps)


Total persons participating in the FNS benefits program during October 2009 increased to 1,518,787 by 14,818 or 1.0% from 1,503,969 persons reported in September 2009. Households increased by 8,292 or 1.2% over September 2009 levels. The total dollar value of FNS related benefits issued during October 2009 increased by \$1,710,905 or 0.8% from \$213,795,102 reported in September 2009 to \$215,506,007 reported in October 2009. The average benefit issuance person decreased by \$0.26 or 0.2% from those issued in September 2009. The average benefit issuance per person decreased from \$142.15 reported in September 2009 to \$141.89 reported in October 2009.




No of OWF Combined Assistance Groups During The Last 25 months








Food Stamp Benefits Assistance Groups
