Re: COVID-19 Related Layoffs/Terminations Aramark at Rocket Mortgage Fieldhouse: 100 Gateway Plaza, Cleveland OH 44115

To Whom It May Concern:

Aramark has experienced unprecedented disruption to our business caused by the COVID-19 global pandemic. Rocket Mortgage Fieldhouse just informed us that it does not anticipate business improving in full for an undefined period of time and will only need our services in a limited capacity, if at all, during this time-period.

Accordingly, this letter will serve as notice of the reduction in force in accordance with the federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. ("WARN") and any applicable state or local WARN laws. The event was caused by COVID-19 related business circumstances that were not reasonably foreseeable at the time that WARN notice would have been required. We regret to inform you that all or most of the Aramark employees assigned to that client account will be or have been affected.

- 1. As a result of the reduction in force described above, Aramark intends to lay off/extend the layoff, reduce hours and/or terminate its employees at Rocket Mortgage Fieldhouse. We anticipate an improvement in business conditions as soon as reasonably feasible depending on the evolving COVID-19 pandemic and based upon our client's business needs but do not yet know when that will occur.
- The specific job titles of our employees affected by this event, as well as the number of our employees in each job classification, are listed on the attachment to this notice.



- 3. There are no bumping rights applicable to these employees.
