## Dear Rapid Response Team:

This is to notify you that as a result of the unforeseen circumstances associated with the pandemic and the declaration of a National Emergency due to the COVID-19, and in order to sustain our business, Arhaus, LLC d/b/a Arhaus Furniture ("Arhaus" or the "Company") will be implementing furloughs for an unknown duration. Although we do not anticipate that the furlough will last more than six (6) months to trigger the Worker Adjustment Retraining and Notification Act, 29 U.S.C. § 2101 ("WARN"), given the uncertainty of the current pandemic, and to ensure compliance with WARN (and any state equivalents), we are providing you with this notice. Arhaus plans to impose furloughs beginning April 3, 2020, at its corporate office location at: 51 East Hines Hill Road, Boston Heights, Ohio, and its Ohio store locations in Fairlawn, Canton, Lyndhurst, Westlake, Perrysburg, Dayton, Columbus, and Cincinnati. This action will affect approximately 350 employees in Ohio. There are no bumping rights.

As you know, the COVID-19 virus recently reached pandemic proportions and the federal government and many states have declared a state of emergency. These sudden and unexpected circumstances adversely affected our business operations and, unfortunately, prevented us from providing notice sooner.
