Re: Beacon Orthopaedics & Sports Medicine / Worker Adjustment and Retraining Notification Act (WARN) Notice

This is to inform the Ohio Department of Job and Family Services, as the designated state dislocated worker unit, pursuant to the federal Worker Adjustment and Retraining Notification Act (WARN) [29 U.S.C. § 2101, *et seq.*], that Beacon Orthopaedics & Sports Medicine plans to conduct a layoff at its facilities located at 500 E-Business Way, 50 E-Business Way Suite 200, 6480 Harrison Avenue and 463 Ohio Pike, Cincinnati, Ohio and lay off approximately 191 employees currently employed at those locations.

This layoff is due to unforeseeable business circumstances in connection with the current COVID-19 pandemic facing our nation, including recent “stay at home” orders from state and local authorities, and for that reason, we are unable to provide more advance notice. We sincerely hope that this will be a temporary layoff of less than 6 months but are providing this notice pursuant to the WARN Act as a precautionary measure and as a good corporate citizen.

The layoff will affect approximately 226 employees and is anticipated to commence on or about March 28, 2020 and conclude as soon as possible after patient volume increases.
