Re: Logan Glass Plant and Bucyrus Lamp Plant

Dear Mayors Reser and Fraunfelter, and Sir or Madame:

This letter is notice per the Worker Adjustment and Retraining Notification Act, 29 U.S.C. 2101 *et seq.* and Ohio Rev. Code 4141.28(C) that Savant Systems, Inc. ("Savant") will permanently separate employees working at the GE Lighting, a Savant company Bucyrus Lamp Plant located at 1250 South Walnut Street, Bucyrus, Ohio 44820 and the Logan Glass Plant located at 12680 OH-93, Logan, Ohio 43138 (collectively "the Plants") due to the closure of the Plants. The total number of employees impacted is 209.

Positions will be permanently eliminated beginning on or about September 30, 2022 with approximately 159 employees released on that date. Of the remaining positions, it is estimated that 34 will be eliminated by December 31, 2022, and the remainder eliminated by July 31, 2023. An exact schedule for all job eliminations is not known at this time.

The job classifications and number of affected employees at each plant are set forth in Attachment A. Both bargaining unit and non-bargaining unit employees are affected. Bargaining unit employees at the Bucyrus Lamp Plant are represented by IUE-CWA; bargaining unit employees at the Logan Glass Plant are represented by the USW. There are no bumping rights.

Notification was provided to Will Evans, President, IUE-CWA Local 704 and Carl Kennebrew, President, IUE-CWA, 2701 Dryden Rd., Dayton, OH 45439. Jeff Ogg, President, USW Local 1017 and Donald E. Blatt, District 1 Director, 777 Dearborn Park Lane – J, Columbus, Ohio 43085 were also notified.

This notice, timetable, and number of affected employees are based upon the best information available as of the date of this notice.
