Dear Rapid Response Team:

This is to notify you that the unforeseen circumstances associated with the COVID-19 pandemic and Sunday's 3/23/2020, Stay at Home Order issued by the Ohio Department of Health for all people and non-essential businesses have required Morris Furniture Co., Inc. to implement temporary layoffs and temporary furloughs for an unknown duration, but which is anticipated to last less than six months given current understanding of the pandemic. Morris Furniture Co., Inc. has announced such temporary furloughs and temporary layoffs on March 22, 23 and 26, 2020 at its various store and corporate locations. The effective date(s) of the temporary layoffs and employee furloughs are March 22, 2020, March 23, 2020 and March 26, 2020. To date the number of employees affected by these temporary furloughs and temporary layoffs is 272.

Additional temporary layoffs and/or furloughs may occur between March 27 and April 6, 2020. Due to the sudden and unexpected nature of the virus outbreak, the timing of the government mandated shutdown announcement, and its adverse effect on our business operations, we were prevented from providing notice sooner and are providing this notice to affected employees as soon as practicable.
