On February 12, 2020 Sodexo received notice from Middletown City Schools that, effective June 30, 2020, the client will no longer use Sodexo to perform Custodial, Grounds, and maintenance services. Thus, on or about June 30, 2020, Sodexo will close its operation at this facility and the employment of individuals there by Sodexo will be discontinued. The client has informed us that Middletown City Schools will be providing these services.
